

Experiential Learning in Academic Programming
Call for Grant Applications
June 2018

McMaster University is launching an **Experiential Learning in Academic Programming (ELAP) grant**. Through this fund, a total of ***\$75,000 is now available to support the development and expansion of experiential learning (EL) opportunities into academic programming.***

Fund Details: The ELAP Grant will provide up to \$5000 to build experiential learning components into course and academic program offerings, including field experiences, research practica, and placements. Special consideration will be given to courses and programs in non-professional programs, where historically there have been fewer EL opportunities compared to programs in our Health Sciences and STEM disciplines. In addition, there will be an emphasis on graduate courses and those that involve placements in industry- and community-based organizations.

All activities supported by this fund must begin during the Fall 2018 or the Winter 2019 term. Successful applicants will be required to report on the project outcomes by March 2019.

All opportunities must meet the following *Guiding Principles for Experiential Learning*:

- The students' experience is situated within a workplace or simulated workplace environment
- The students are exposed to authentic demands that improve their employability, interpersonal skills, and transition to the workforce
- The experience is structured with purposeful and meaningful activities
- The students apply academic program knowledge and/or essential employability skills
- The experience includes students' self-assessments and employer/university evaluation of the students' performance and learning outcomes
- The experience counts towards course credit or credential completion

All grant applications are expected to meet one or more of the following goals:

- Develop, improve, and/or accelerate institution-level capacity to undertake and expand experiential learning programs both domestically and abroad
- Improve the capacity to evaluate and verify current and future EL opportunities
- Increase the quantity and quality of EL opportunities unique to McMaster's context and strengths
- Promote institution-wide best practices for engaging in EL
- Improve access to EL opportunities for students who, without interventions and support, might not otherwise participate in EL opportunities in postsecondary education
- Expand opportunities for EL abroad (e.g. undertaking service learning with an NGO or a local multi-national organization that has international work locations)

5. **Openness to Learning:** Change takes time. We are committed to continually learn from and evaluate our work together, reflecting on and sharing both our successes and failures to grow as individuals, partnerships, and communities.
6. **Commitment to Act:** We aspire to make a positive difference in our community by sharing and acting on our knowledge to contribute to the greater social good.

Note: The grant is intended to provide seed money and is not to support ongoing expenses. Eligible expenses could include teaching or research assistants, travel costs for off-campus activities, and honoraria for community partners. When using project funds to hire personnel, McMaster University will be the employer; therefore Project Supervisors must pay appropriate wages and benefits at established rates. When hiring students as research assistants, consider securing supplementary funding through, for example, the McMaster Work Programs (Ontario Work Study Program, McWork, the MacPherson Student Partners Program, or International Student Work). Ineligible expenses include, but are not limited to, reimbursement to faculty members, professional memberships, off-campus commercial services, travel, accommodation and food expenses for conferences, and the purchase of alcohol for focus groups or similar meetings.
